ARTWORK

Exhibited artwork must be **designed & executed** by the **accepted artist who must be present** during the fair. Commercial molds, patterns or kits, **resale** of purchased items **not allowed**. **NOTE: Signed & numbered reproductions of your work are acceptable, but should not be labeled as prints.** Consumables are not accepted. Use of trademarks/logos in artwork must have express permission of the trademark/logo owner.

ARTISTS

Artists must be juried. Four (4) images required: three (3) **close-ups** of artwork; one (1) of overall display. Images may be presented on photographs, CD or Email (**Jpeg**). Images should be professional quality and recent images representative of your **current** work to be displayed & sold at the Fair. We reserve the right to request removal of work that is inconsistent with quality or media category of art submitted for jury consideration.

DEADLINE

Application must be postmarked by **March 1, 2020** to be listed in the Art Fair program. All fees, images and a stamped, self-addressed envelope must accompany the application. Accepted artists will receive a map of the Fair area; assigned space number; information regarding registration, parking & set-up information, and a list of area accommodations, if requested. Artist notification of acceptance or non-acceptance will occur no later than March 25, 2020.

FEES

Two checks must accompany application: **(1)** - Application Fee: \$20 and **(2)** Booth Fee as follows: Postmarked on or before 3/1/20 - **\$225**. After 3/1/20 - **\$250**. (If App Fee & Booth Fee are on one check it will be cashed when received.) Cancellation Fee after May 1: \$50. **Refunds after June 15 will be at discretion of Art Fair Chairpersons. No refunds after Tuesday of Art Fair week.**

If not accepted, the booth fee check and photos/CDs will be returned. Accepted artists' images will be returned *during* the Fair. Credit card payment can be taken by phone.
